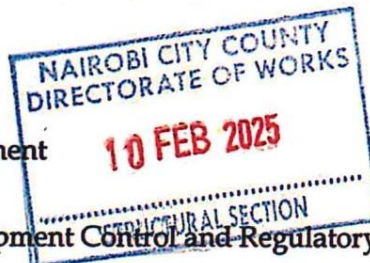

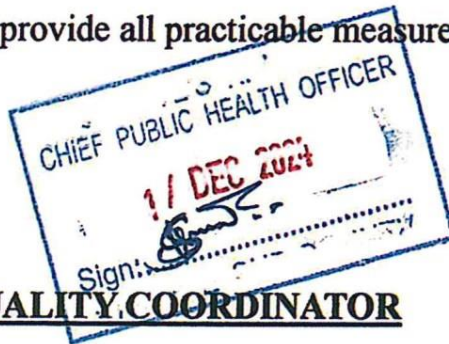
#### SAFE DRINKING WATER CERTIFICATE
